- a. Township Planner Steve Cassin County will here next month for the Public hearing on the Master Plan and Recreational Plan. Site Plan has been submitted for the Campground on Water St and a Site Plan on Dove Rd has been submitted for Auto Salvage yard but the site plan is insufficient.
- b. Township Board Reports John Reno Fire Chief Randy Vasper has resigned and have promoted within the Fire Department Andrew Persig is the new Fire Chief. Strawberry Lane is going to be repaved and be widened shoulder on the East side, this will make more desirable and safe for walking and biking path.
 - i. Stephen Tetreau asked if the Flag at Bakers Field can be replaced. Inquired if the Township had any old maps and or pictures of the big Flood 1996, wants something that they can show applicants of the water levels when basins if they are not done correctly and the aftermath. Drain office has topography maps of water flows also liber maps.
 - ii. Sheri Faust update on the Green Storm Water projects; Supervisor Lewandowski brought up to the Township Board Bakers Field was denied for the Bi-swale retention in the parking lot and requesting more information on Bakers Field. Memorial Park, passed in the amount of 1 million project for Shoreline protection restorations and Soil Erosion protection and streamline habitat.
- c. Zoning Board of Appeals Amy Hurd, 3665 Dove Rd requesting a variance for a salvage yard on 4 acres and Township ordinances states must have 5 acres, and of a minimum setback of 200 feet from a resident dwelling. Variance was denied.
