CAPITALIZATION POLICY

WHEREAS Port Huron Township desires to update its current capitalization policy and establish a new minimum capitalization amount; and

WHEREAS Port Huron Township further desires to define the term "capital asset" and determine those capital assets that are recorded on Port Huron Township's annual financial statements, reports and tax returns; and

WHEREAS Port Huron Township wishes to further ensure that that capital asset transactions are accounted for consistently and in accordance with generally accepted accounting principles;

NOW, THEREFORE, BE IT RESOLVED that a capital asset is defined as a unit of property that has an economic useful life that extends beyond 12 months, and

BE IT FURTHER RESOLVED that Port Huron Township establishes the capitalization threshold for various assets as **\$5,000.00**.
