### **New Business:**

Port a potties need to be ordered for parks.

Bob Lewandowski would like the horse shoe pits (double) put back in Memorial Park.

Keller Williams would like to donate benches for Memorial Park.

Bob Lewandowski received a copy of the print laid out for Wm P. Thompson Pond.

### **Park Reports:**

#### **R.V. Park #2:**

Diane reported the electric keeps tripping at the pavilion. Diane received a quote from Russell Electric in the amount of \$2,235 for upgrade.

Roads need to be cleaned up and grated.

#### **Memorial Park #3:**

The slide will have to be removed - doesn't meet standards. It was suggested a handicapped double swing that has a seat for the parent and/or care giver. The sidewalk is already in place for wheel chair access. The cost of the swing would be \$9,975.

Motion by Crowe, support by Whitmore to purchase the handicapped swing for \$9,975.

Nancy met with Don and Nancy Duman, manager, regarding the Keller Williams group helping with clean up on May 10<sup>th</sup> starting at 8am. Discussion of the work that needs to be addressed. Lunch will be provided for the volunteers.

#### **Wm P. Thompson Pond #4:**

A discussion/suggestion to move the kayak launch to the first dock, would be more accessible for those using the launch. The sidewalk is already in place.

The donation of 10 hours of service from Capac Hardwood Lumber Company could be used for moving.

Another dock needs to be picked up and put back on the cement block.

#### **Hoover School Park #6:**

Graffiti on the slide and will need to be spray painted, also sidewalk and poles.

Basketball nets (4) will need to be replaced. Additional sand for sand box.

The park sign needs to be updated.

Cushion material under all of the play ground equipment

Suggested to have Vickie clean up flower beds.
