 - a. Motion by, Jerry Sebastian supported by Mike Bacheller to approve the agenda as present, Chairman Tetreau called all in favor, motion carried
- 5. Approval of Minutes October 13th 2022
 - a. Motion by, Laura Covyeow, supported by Trustee John Reno to approve the minutes as present, Chairman Stephen Tetreau called all in favor, motion carried.

- 7. General Public comment:
 - a. Sheri Faust spoke and explained a concept design plan created by SEMCOG for the Black River shoreline in Memorial Park. SEMCOG received a Michigan Coastal Management Grant from EGLE to complete this work. They worked with the Center for Watershed Protection to complete green infrastructure and shoreline assessments aimed at building coastal resilience in the region. Port Huron Township's Memorial Park was chosen as a high-priority, publicly-owned property that would benefit from green infrastructure to stabilize the shoreline to reduce erosion and flooding. The design plan can be used by the township for future funding opportunities.

 - Motion by Jerry Sebastian to accept the change of section 3 as İ. presented, Supported by Mike Bacheller discussion Motion was rescinded.
 - Motion by Jerry Sebastian to make changes to ordinance 40-669 ii. to add wording in C3 "In the case of a corner lot, both street

frontages are considered a front yard" and add #5 under Section C "In the case of a rear yard abutting a side yard of another property, the minimum setback shall be Fifteen (15) feet" and renumber coordinating. Seconded by Sheri Faust, Chairman Stephen Tetreau called all in favor, motion carried.

 - Sheri suggested special language be placed into the Master plan to match some of the county's master plan changes specifically related to sustainability, climate resiliency, and planning for coastal and climate trends
